 CHECK-OUT PROCEDURE LIST
Put life jacket on all children under 13 and all non-swimmers before loading.
No alcohol or drugs used by the operator.
Gas tank is full. Return to the gas dock to refuel during rental and when returning the boat. You are responsible to pay for fuel used.
No smoking near gas dock. Always use care when smoking in the boat.
Idle speed while inside marina. No wake zone... Watch for shallow water buoys as well.
Tubing: Must have 3 people... Orange Flag Law; Motor OFF when loading/unloading; Find a cove; stay away from shore and other boat traffic. Stay between Point 9 and Point 15. GIVE MAP: Point out Danger Zone by Virgin Bluff.
Stay away from skiers, jet skis, fishermen, high traffic areas, and 200ft from scuba flags!
Head-On situation: reduce speed and turn right. Crossing: Boat on right has right of way.
Stay 200ft from boats, shoreline, docks, and exposed trees at all times.
Safety equipment on board: __Extinguisher __Cushion __Life Jackets __Horn
Demo: Key on-off and show how to use safety switch/lanyard.
Demo: Show how to use the control lever: Neutral, Forward, and Reverse.
Reminder: NO BRAKES – Use neutral to control speed. One hand on wheel and one hand on lever at all times.
Demo: Show how to use: __Radio __Ladder __Trim
Ticket from the Water Patrol = forfeit of rental unit with NO refund.

Limitation on Use: With respect to the operation of the watercraft during the use period, Lessee and Operator herein agrees to comply with the following as well as all other limitations, instructions, and responsibilities listed in the Agreement and Check-Out Procedure List:

1. The Operator of the watercraft is responsible for the safety and welfare of all passengers on the watercraft.
2. Only Lessee and other Authorized Operators are permitted to operate the boat.
3. Do not operate under the influence of alcohol or drugs: No alcohol for operator.
4. Observe all safety precautions and applicable state and federal boating laws/regulations.
5. Obey no wake buoys; operate at idle speed while inside marina.
6. Stay at least 200ft. from all other watercraft, docks, and shoreline while not at no-wake speed.
7. DO NOT BEACH watercraft or pick-up passengers on shoreline.
8. Do not operate watercraft in less than 5 ft of water.
9. Do not tie up or make contact at any time with another watercraft.
10. Do not carry more than stated as the maximum number of passengers allowed for the watercraft.
11. No refunds for early return or due to weather.
12. **GAS IS NOT INCLUDED IN BOAT RENTAL FEE.** Upon return, watercraft is refueled and Lessee pays for gas consumed.

By signing this agreement, the Undersigned certifies, agrees, and understands all terms, conditions, and obligations outlined herein, and further certifies that lessee or other operators is not now, nor will be, at any time during the operation of the watercraft during the rental period, under the influence of alcoholic beverages, drugs, or any other impairment.
